FACILITY:

Keating Natatorium is an 8 lane x 50 meter indoor pool with a removable bulkhead in place to make two 25 yard competition pools. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming. Water depth is 6ft. from the balcony (South) end of the pool to 4ft. in depth at the Scoreboard (North) end of the pool. The Natatorium will open to the public 30 minutes prior to the start of the warm-up session. No coolers or glass containers are permitted in the natatorium. Swimmers bags are not permitted in the spectator seating. No towels, bags or personal belongings may be left in the natatorium between sessions. For your safety and the safety of others exit aisles and exit ways must remain clear at all times. Thank you for your cooperation.

ENTRIES: **This is a closed competition. Entry by INVITATION ONLY.**
Entries must be received no later than 12:00p.m. On **Monday, Nov. 7, 2011.** We encourage HYTEK entries made via e-mail in HY-TEK form to CMentries@fuse.net Please forward a hard copy of your entry with your payment. No Team will be permitted to participate unless their Fees are paid in full.
DECK ENTRIES: NO DECK ENTRIES will be accepted.

ENTRY FEES: \$4.00 per individual event, \$7.00 per Relay and \$2.00 surcharge per swimmer. All entry fees must accompany entries to complete the entry process. **Please pay by check made payable to the Cincinnati Marlins, Inc.** All fees must be paid before you will be allowed to swim.

RULES: Age on first day of meet will determine eligibility for age group divisions. Current USA Swimming rules will govern the meet. Swimmers aged 11 & Over may compete in the Open events. All swimmers are limited to entering **in 4 Individual events per day** plus Relays. **Teams may enter as many relays as they wish but only two (2) may score in each age group.**

TIME STANDARD: No Time Standard

ELIGIBILITY: All swimmers must be registered with USA Swimming. Registration numbers and swimmer age must appear on the entry forms. **All SWIMMERS MUST BE PREPARED TO PROVE USA SWIMMING REGISTRATION.**

SEEDING: This meet is Dual Meet seeding.

SCORING: Scoring Top 16 Individual places. Only Four (4) Swimmers from each team will be eligible to score points in these events.

Individual: 20,17,16,15,14,13,12,11,9,7,6,5,4,3,2,1.

Relays: Scoring Top Eight (8) Relays. Only Two (2) relays from each team will be eligible to score. 40,34,32,30,28,26,24,22.

AWARDS: Individual - Medals – First through Third place – Ribbons, Fourth through Sixteenth place.
Relays - Medals - First Place – Ribbons, Second through Eighth.
Team – SwimVille USA Challenge Cup - 1st Place Only.

SAFETY: Ohio Safety guidelines will be enforced in the conduct of the meet as well as warm ups. General Warm-up procedures require swimmers to enter the pool feet first in a cautious manner, with one hand on the deck. . **As required by (202.3.3) “Any Swimmer entered in the Meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming Member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer’s legal guardian to ensure compliance with this requirement”.**

COACHES: ***ALL COACHES MUST SIGN IN FOR EACH SESSION AND PRESENT A CURRENT USA SWIMMING MEMBERSHIP CARD UPON ENTERING THE POOL.***
This card must be worn while the coaches are on the pool deck. Ohio Swimming requires the Cincinnati Marlins to enforce this rule. The Marlins are happy to provide a Coach Hospitality Area at our meets. Please indicate the number of coaches that will be attending the meet with you on the Entry Summary Sheet so that we can provide heat for everyone.

DIRECTIONS: From I-75 take Exit 9 and go north on Paddock Rd. (Rt. 4) to North Bend Rd. (The first left turn after crossing under the railroad trestle). Turn left and follow North Bend Rd. to the top of the hill (about 1-1/2 miles) . St. Xavier High School is on the right and Keating Natatorium is behind the school.
